



Other information

- * by Jan 2016 all papers submitted in 2013 will be published
- * EIC estimates 4-5\$K page charges for 2015, increasing in 2016
- EIC worried about backlog (about 75\$ per page is the cost of including additional pages)
- President Rassa has approved a total of US\$28K to be used for publishing an additional 375 pages in 2015. The Journal's original page budget for 2015 is 1200 pages.
- * There has been voiced a desire to consider starting a new journal-a journal on risk analysis. President Rassa, the VP-publication and EiC suggest that SC should not involve itself in starting another journal at this time. The EiC will keep us apprised. The VP-technical operations Roger Oliva is also informed
- * EIC Piuri's present term as EIC is ending. Vin has offered to serve another term as EIC of the Journal. The new term begins in 2016. President Rassa has notified Vincenzo that he would make the reappointment
