From Website: Requesting a Speaker

- DL program primarily for Chapters & Sections
- But open to any IEEE entity
- Instructions for requesting a speaker
- Reimbursements require authorization
- Identifies what the requestor provides
- Identifies what the speaker provides
- Identifies records that should be kept
- [Includes Evaluation Form](#)
- Maximum of three visits per year, per chapter
- Financial guidelines

From Website: Becoming a Speaker

- Topic must be relevant to Systems Council
- Topic successfully presented previously
- Invitees follow same process as volunteer speakers
- [Speaker enrollment form](#)
- Send form & presentation slides to DL Chair
- DL Review Committee will review
- For accepted speakers, presentation topic may be accepted “as is” or “with changes,” including elaboration or extensions
- Include slides about the Systems Council & DL Program
- DL Committee ineligible to participate in review of their slides

From Website: Financial Guidelines

- Systems Council, with the support of AESS, will reimburse up to \$500 US per speaking event in North America
- Will reimburse half, up to \$1500 per trip outside North America
- For speakers not from North America, SC will determine an appropriate regional budget allocation.
- Speakers should purchase economy class tickets
- Speakers should not exceed local expenses as per host chapter
- Expense reimbursement will be via the Systems Council Treasurer.
